Chairman Bradley Jensen was attending legislative meetings in Boise, in his absence Vice Chairman Sim Weston Conducted the January 31, 2024, meeting of the Bear Lake Regional Commission, the meeting started at 7:12pm.

Approval of Agenda

Commissioner Sim Weston asked for an approval of the agenda, The agenda was reviewed and approved.

• Dan Fisher motioned to approve the agenda. Burdette Weston seconded the motion. Motion carried.

Election of Officers

A unanimous decision was made to suspend the election rules and install Commissioner Sim Weston as Chairman rotating from Idaho to a Utah representative for this upcoming year, with Commissioner Bradley Jensen as Vice Chairman and installing Montpelier councilman Dan Fisher as secretary/treasurer.

• Ken Brown made a motion to suspend election rules and install Commissioner Sim Weston as board Chairman and Commissioner Bradley Jensen as Vice Chairman for the 2024 year, with Dan Fisher as secretary/treasurer. Burdette Weston as alternate primarily for the signing of checks when necessary.

Mike Leonhardt seconded the motion. Motion carried.

Margie Rycewicz/ Rich County Local Administrative Adviser

Margie is the new Local Administrative Advisor. She is from The Bear River Association of Governments. BRAG has been subcontracted by the Utah Legue of Cities and Towns to help small municipalities. Every municipality in Rich County is a small municipality, and the County itself also qualifies for assistance under this program. Due to the small size and lack of full staff in these communities, Margie is able to come help and identify and prioritize needs. Some of the tasks the program can help with are, setting and evaluating budgets, looking at compliance with State and Federal procedures and operating rules, personnel management, grant writing services and any other administrative activity except for land use planning. (However, BRAG has other funds and other programs that may help with those issues).

Twenty-Seven communities in the three-county region qualify for this service.

The Utah Legue of Cities and Towns has told BRAG they can expect this program to last at least two years and they intend to lobby for future continuation of the funds.

Casey Silva/ Update on Local AIS program

Casey is with the Utah Department of Natural Resources, Division of Wildlife Resources. She is the new AIS Program Coordinator.

Statewide inspection and decontamination numbers are up this year. Higher staffing and a lot of recruiting, they gave statewide wage updates with higher wages at Lake Powell to recruit as many employees as possible. Implementation of a camera system at lake Powell has been installed, cameras are now at the entrance and exit of Wahweap and Bullfrog. They are working with an AI company to scan bow numbers so if technicians are not available, they are still catching who is coming in and out of Lake Powell. Eventually this will get integrated into their WID app so those bow numbers will just get logged in, then technicians in other areas will be able to see that.

Dip tanks have now been installed at Utah Lake, Sand Hollow, and Willard Bay. Completion of tanks at Flaming Gorge & Bull frog should be completed by June 30, 2024, making a total of five Dip tanks across the state. These Dip Tanks are similar to an inground swimming pool with a boat ramp. Using high temperature water these tanks turn an hour to an hour and a half manual decontamination into a ten-to-fifteen-minute process.

Josh Wright the DNR-Invasive Interdiction Specialist informed the board that this past season in the Bear Lake area 27,790 boat inspections were done. 11,488 were done at the State Park, 16,302 at the overlook. 6,540 wakeboard boats, which are one of the highest risks. 12,951 hand launch, the estimated for hand launch is probably double because many do not stop for inspection of hand-launched crafts. Under State Parks law enforcement, 42 citations were issued. 27 reports, 130 law enforcement hours. This is not the total of law enforcement hours as other officers and agencies also help.

Contracts with all of Utah State Parks are being finalized for reimbursement costs to the Parks to help with the program.

Mitch encouraged the board as County Commissioners and local elected officials to reach out to members of that committee and let them know that you support this and would appreciate their consideration for this funding. Representative Sandals chairs that group. Some other members of that committee are Representative Chew, Casey Snider. The current Director of Natural Resources is Joel Ferry.
