- Hawk Rock, one of the 7 Phases of Long Ridge Development-Ken Hansen's project. Accessed from Hodges Canyon.
- Bear Lake Vista 80 homes on west side of highway across from the Chevron on Hwy 89. The 2<sup>nd</sup> and 3<sup>rd</sup> Phase will be on the same side as the Chevron. Issues of crossing the highway are still being looked at.
- Osprey -North of Hawk Rock, Osprey is just getting started.
