## Approval of Agenda

Commissioner Jensen asked for an approval of the agenda, The agenda was reviewed, and approved.

#### Staff Report

We Submitted a grant proposal to the Utah Office of Recreation for \$560,000 to help with the bike path from Gus Rich Point down to Rendezvous Beach State Park. We should be informed if we receive the Grant by tomorrow.

Bear Lake County is looking into approving a Short-Term Rental Ordinance. Their Planning and Zoning Commission is comparing Caribou County, Rich County & Garden City's Ordinances to develop one for Bear Lake County.

Mitch has attended several meetings this month including the Bear River Water Quality Task Force meeting, Bear River Water Quality Committee meeting and the Bear River Preservation Advisory Committee meeting. The BR Preservation Advisory Committee meeting is where Rocky Mountain Power makes their projection on water flows into Bear Lake for the year. At the time of the meeting

they projected a 50% chance that the Lake would hit 5916, and two weeks later they raised that by two feet. So they predict a 50% chance that the Lake will hit 5918. And a 10% chance that it will hit 5921. The Lake Maximum is 5923.65.

We are preparing the budget, and are getting on that early, hopefully to be approved in May. We have already signed the contract with Idaho to get our funding in. If this money comes a couple of months earlier than normal it will help alleviate the money stress that normally happens those last couple of months before the next year's funds come in. Funding discussion followed.
